
INSTRUCTION MANUAL

POWER

This antenna can be powered by either the included AC power adapter, or by connecting the included USB power cable to a Laptop or PC. It is not necessary to connect both cables to power the antenna.

AC Power Connection

Connect the supplied AC adapter cable to the back of the Antenna. Connect the AC adapter to a standard AC outlet.




USB Power Connection

Connect one end of the supplied USB power cable to the back of the Antenna.

Connect the other end of the USB power cable to an open USB port on your Laptop or PC.

Now the USB Cable can power the TV Antenna.

Note: Contact your PC manufacturer to check if there are any software updates needed for this operation.



Connect to TV

Connect the end of attached coaxial cable to the TV's RF input socket.



Adjusting the Antenna

This 360° Omnidirectional Antenna should not require moving positions to find the best reception. In some locations where signals may be very weak, try to re-position the antenna for the best signal.




Attaching the Stand (optional)

This antenna comes with an optional stand. (Pictured below)




To attach the stand to the antenna, insert the stand into opening near the bottom of the rear of the antenna. (Pictured below)


Note: Make sure to properly align the top of the stand with the opening as shown.



When complete the antenna should rest at a slight angle when sitting on a flat surface.
